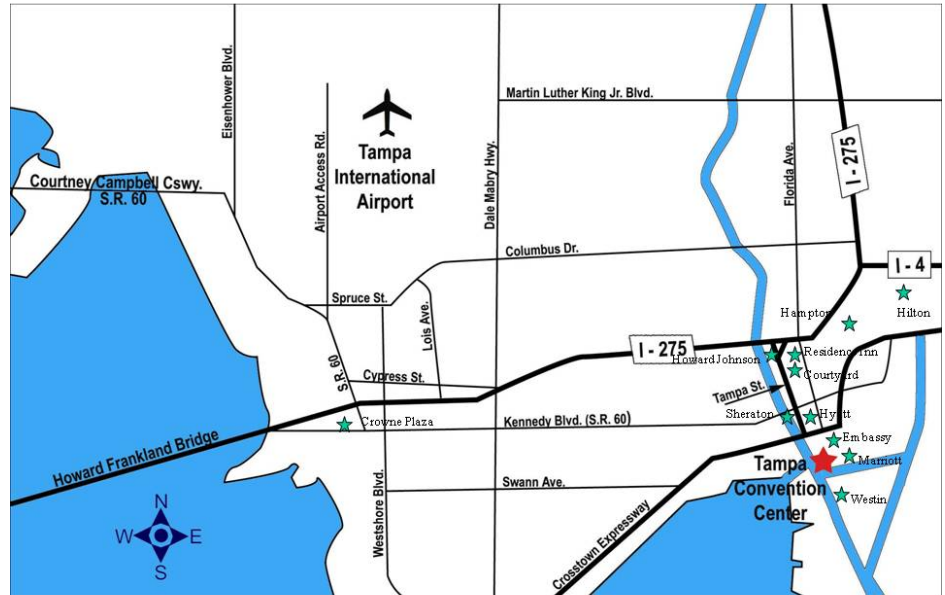

Housing Guidelines

- Though the AFCEA Housing Bureau will remain open through July 26, 2010, please note that to take advantage of the special rates for the LandWarNet Conference, book your reservation by July 12, 2010 through the AFCEA Housing Bureau. AFCEA cannot guarantee rates and availability at the conference hotels after July 12, 2010. After this date, the official LandWarNet room blocks may be released and the hotels may charge significantly higher rates. Reservation requests must be sent directly to the AFCEA Housing Bureau through July 26, 2010. **Do not send the housing form to AFCEA Headquarters or individual conference hotels; it will delay processing your request.**
- A credit card guarantee of one night's room and tax is required with each reservation request. Housing forms received without a valid credit card will be returned and will not be processed. Credit cards must be valid through August 31, 2010 to be considered a proper guarantee. **NO CASH OR CHECK DEPOSITS ACCEPTED.**
- Rooming lists for blocks of ten or more rooms must be submitted in writing and faxed to (813) 218-3369 no later than June 12, 2010.
- **Though the AFCEA Housing Bureau will remain open until July 26, 2010 to assist with new reservations, changes or cancellations, please note the following cancellation policy. Reservations can be cancelled through June 12, 2010 without penalty. After this date, a non-refundable penalty of one night's room and tax will be charged for any INDUSTRY cancelled reservation.
